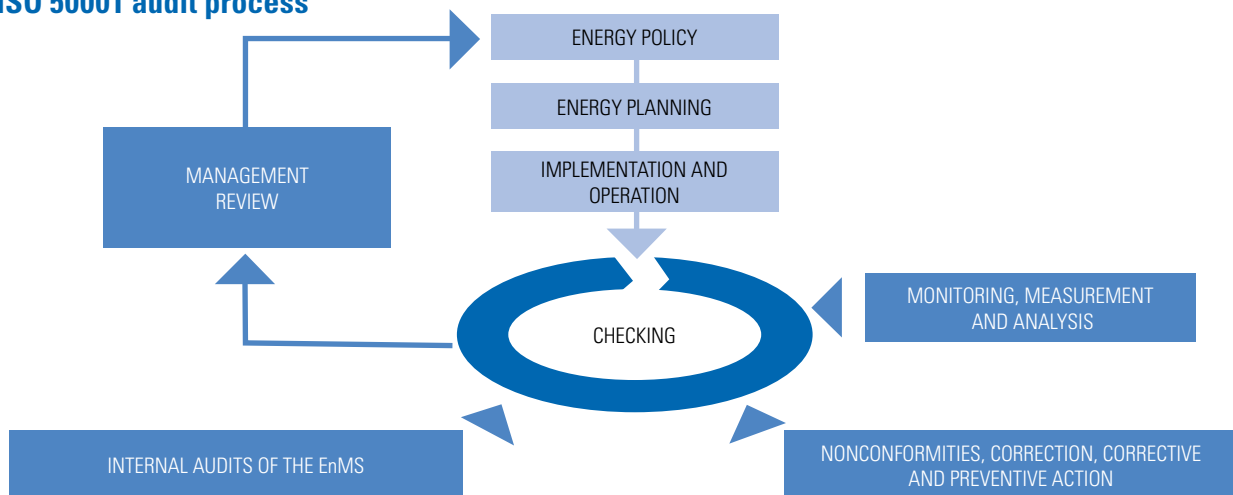
Why is ISO 50001 important for your business?

■ Pre-audit (optional)

A preliminary evaluation determines which requirements your company already fulfils.

■ Audit level 1 and subsequent documentation review

We collect information on the basic EnMS processes, prepare the certification audit and check for compliant documentation.

■ Certification audit

We assess the practical implementation of your company's EnMS, including interviews with different members of staff, review of facts and figures, and site inspection.

■ Awarding the certificate

The certificate is awarded, confirming that your EnMS conforms to the ISO 50001 standard.

■ Surveillance audits

Our annual surveillance audits provide ongoing support in the continuous optimisation of your processes.

■ Re-certification

ISO 50001 certifications are valid for three years, after which your company needs to be re-certified.
